CHAIR'S MESSAGE

This year marked an incredible milestone in the history of the Forde Foundation.

For 20 years the Foundation has enhanced the quality of life for Forgotten Australians and other care leavers through its grants program.

Established 20 years ago with an investment of \$4.15M from the Queensland Government, it is remarkable to realise that since commencement there have been over 5,657 grants valued at \$3.27M.

Our small grants program helps to make a difference to the lives of people who suffered abuse or neglect in Queensland institutions. While we are proud of the Foundation's achievements, we know that we could do so much more if we had additional funds, and our Board is driven to find new ways to extend the resources we have so we can provide more help and assistance.

2020 was a challenging time for all Trust Funds and the impact of COVID-19 has put immense pressure on our Forde Foundation finances. There is further discussion about the Board's approach later in this report.

There are many people to whom I owe thanks. Every connection has made an impact on me and for that, I thank you. Sadly, this will be my last Impact Report as Chair of the Forde Foundation. In May 2021, I will have completed the end of my third and final term. This is the maximum period I can serve on the Forde Foundation Board of Advice. I am exceptionally proud of the work and achievements of our Board but more than the work we have accomplished it has been a privilege to walk alongside so many brave and courageous Forgotten Australians.

FORDE FOUNDATION

The Foundation is a perpetual and independent charitable trust that exists to improve the lives of Forgotten Australians and other people who were in the care of Queensland institutions or foster care as children.

The Foundation's mission is to enhance the lives of Forgotten Australians, and other people who were in the care of Queensland institutions or foster care as children, through the provision of a transparent and easy to access grants program.

OUR VISION

- We lead a sustainable, perpetual trust that helps improve the quality of life for Forgotten Australians and other people who were abused or neglected in care, through advancing their health, education and welfare.
- We pay respect and honour the experiences of Forgotten Australians and other care leavers who were abused or neglected in institutions and systems that were meant to support and care for them as children.
- We acknowledge the disadvantages many Forgotten Australians and other care leavers have had to overcome as a result of their childhood experiences.

OUR IMPACT

Since 2000, the Forde Foundation has provided:

GRANTS PROGRAM

The grants program provides Australia-wide assistance and targeted financial support in the areas of education, employment, health and well-being.

There are three types of grants - dental, personal development and health and well-being.

One of the grants that has the greatest personal impact is the dental grant. Interstate applicants can choose their own private dentist or those who live in Queensland can choose between their private dentist or a Queensland Health dental clinic.

A Letter of Intent between the Forde Foundation and Queensland Health allows dental grant recipients to receive a course of free dental treatment without being on public waiting lists.

The personal development grant can assist applicants to:

- Improve their life skills so they can live more independently
- Improve their employment opportunities by gaining a certification or qualification
- Develop an interest in activities that are of therapeutic benefit.

The health and wellness grant can assist applicants to:

- Improve their ability to live more independently at home or with their families
- Maintain or enhance their connection to their community
- Maintain or enhance an active lifestyle
- Support their needs to improve their immediate quality of life
- Maintain or enhance their general health and wellness.

Grants are assessed by the Board of Advice at the end of each calendar quarter. The recommendations from the Board of Advice are provided to the Public Trustee of Queensland for final approval.



OUR ENVIRONMENT



The COVID-19 context has impacted across the world. The Board of Advice recognises that Forgotten Australians and other care leavers are likely to be experiencing significant impacts from the pandemic. We note in particular the possibility of financial, mental and physical health impacts, possible difficulties in accessing services and supports in the community, and possible social isolation.

As such, the Forde Foundation Board of Advice has determined that, although we are operating with less money available for grants, we will continue to support the needs of Forgotten Australians and other care leavers through our grants program.

We have identified the following priorities:

- Laptops and communication devices to assist people to access services from home and to connect with others
- Needs emerging relating to COVID-19 hotspots
- Other emerging needs related to the pandemic.

It has been two years since the commencement of the National Redress Scheme for people who experienced institutional childhood sexual abuse. We acknowledge the concerns that continue to be raised by survivors of abuse and their advocates in their experience of the Scheme. We continue to monitor the way the Scheme operates and offer support and advocacy where we can.

We note that the Royal Commission into Aged Care Quality and Safety has continued throughout the year. We provided a submission to the Commission, highlighting the difficulties that can be experienced by Forgotten Australians and care leavers as they age, particularly relating to the barriers to accessing aged care, the complexity of health and social needs of some Forgotten Australians and care leavers and the concerns of some Forgotten Australians and care leavers as they face residential aged care and re-institutionalisation. We welcome the proposed recommendation from Counsel Assisting the Commission in relation to mandatory trauma-informed practice training for those working with older people and hope that this proceeds to final recommendation and implementation.

We welcome the announcement of funding for a memorial for survivors of abuse. We note that a collaborative, co-design process is underway and we hope this creates a place of solemn and appropriate remembrance and reflection for survivors of abuse and their families, and for the whole community.

OUR PATRON

Ms Leneen Forde AC



In 1998, the Honourable Ms Leneen Forde AC was appointed to Chair the Commission of Inquiry into Abuse of Children in Queensland Institutions. The Commission of Inquiry has become known simply as the Forde Inquiry and it was the first inquiry into child abuse and neglect in institutions in Australia. The subsequent report was tabled in the Queensland Parliament in June 1999.

In the foreword of the report, Ms Forde dedicates the report to those who came forward to tell their stories and to all the victims of abuse in institutions and hoped that it would be a small step on the long road to healing and reparation.

The Forde Foundation was established in 2000 as a result of the Forde Inquiry and Ms Forde was the founding Chair of its Board of Advice. She held the position for seven years before accepting her current role as Patron of the Forde Foundation.

Prior to the Forde Inquiry, Ms Forde already had a distinguished career. Born Leneen Kavanagh in Ottawa, Canada, Ms Forde worked as a medical laboratory technician and studied part-time for a Bachelor of Arts before moving to Australia in 1954.

Ms Forde worked in the Haematology Department of Royal Brisbane Hospital for two years before commencing full-time legal study following her husband's death in 1966. She graduated with a Bachelor of Laws from the University of Queensland in 1970 and began her career as a solicitor. From 1974 to 1992, she was a Partner of Cannan & Peterson legal practice and in charge of probate and estates.

Ms Forde was appointed a Companion of the Order of Australia in 1993 and is a Dame of Grace in the Order of St John of Jerusalem. She was International President of Zonta from 1990 until 1992 and Queenslander of the Year in 1991. From 1992 to 1997, Ms Forde was the Governor of Queensland. She was the first woman to take on the role in Queensland and the second woman to be appointed to the position of Governor in Australia.

Ms Forde was the Chancellor of Griffith University for 15 years, from 2000 to 2015, and continues to serve her community.

OUR BOARD



Mr Rob Ryan - Chair (since 2013)

Rob is the Executive Lead, Strategic Partnerships and External Engagement (Child, Youth and Families) with Life Without Barriers and he also runs his own consultancy business. Prior to this role Rob was the CEO of Key Assets, a not-for-profit children, family and community service agency and he had responsibility for services across Asia-Pacific. Rob has worked in a range of senior roles in both Government and Non-Government for more than 27 years. Rob has previously held Board responsibilities with the National Association for the Prevention of Child Abuse and Neglect (NAPCAN – QLD Branch) and was the Deputy Convener of the Australian Broadcasting Corporation (ABC) Advisory Council. Rob has a long commitment to Forgotten Australians and this is his third term on the Forde Foundation Board.



Ms Jo Searle (since 2012)

Jo has significant experience in the education and human services field, including at senior levels across both government and community sectors, and led the delivery of the Queensland Government Redress Scheme which commenced in 2007. Ms Searle is currently an Independent Decision Maker for the National Redress Scheme.



Professor Susan Dann AM (since 2014)

Susan is Professor of Marketing and Foundation and Head of the National Peter Faber Business School, Australian Catholic University. Susan's publications include eight books, with two shortlisted for awards. Susan's not-for-profit board experience includes St Vincent's and Holy Spirit Health, Ozcare, Quality Improvement Council, AFL Queensland and General Practice Queensland. She served on the Social Security Appeals Tribunal and is a Queensland Civil and Administrative Tribunal member. In 2018, Susan was awarded the Member of the Order of Australia for her contributions to business education and social marketing.



Ms Dawn Juratowitch (since 2014)

Dawn is a social worker with more than 30 years' experience working in the area of child protection, and in direct services and senior management positions in Queensland and New South Wales. She was on the editorial board of *Child Abuse and Neglect: The International Journal*. She is currently the Director of a professional practice providing counselling, mediation, strategic engagement and assessment.



Mr Kevin Mar Fan (since 2014)

Kevin chairs the Ernst & Young's Diversity and Inclusion Committee and leads the firm's Technology Risk practice in Queensland. He's a Chartered Accountant and Certified Information Systems Auditor who brings more than 20 years' experience across both public and private sectors in Australia, USA and Europe. Kevin currently serves on the Board of Logan Together and Loreto College Coorparoo. He's also Past President and current Director of the Information Systems Audit and Control Association (ISACA) Brisbane Chapter and has served on several ISACA global committees and working groups.

Following a career in social policy, legislation review and development in the Queensland Government, Sarah began work in UnitingCare Queensland (UCQ) in 2013. A large part of her role was monitoring and understanding the lessons coming out of the Royal Commission into Institutional Responses to Child Sexual Abuse and how they impacted on UCQ across the breadth of its services. During this time, Sarah dealt with many survivors of abuse who were seeking to engage with UCQ. Now as National Director of Uniting Church Redress Ltd, Sarah continues her commitment to righting the wrongs of the past and to restoration of relationships for survivors, the Church and the broader community.

FINANCIAL SUMMARY



COVID-19 has had a significant impact on the Forde Foundation's finances in Financial Year 2020 (FY20).

In particular revenue is down by three-quarters compared to FY19 as investment returns have dropped sharply.

The value of the Foundation's investments upon which it derives income also decreased resulting in a net loss on financial assets held at fair value of \$136,622 being recognised in FY20.

This loss together with the reduced income resulted in an operating deficit of \$93,044 in FY20.

Looking ahead, the ongoing uncertainty in financial markets will likely mean income and investment values remain low for some time, so the Foundation will need to make some tough decisions around grant prioritisation during this period.

The Board of Advice is conscious that many Forgotten Australians and care leavers have been disproportionately impacted by COVID-19 and we are continuing to consult with the Public Trustee of Queensland on strategic options for the Forde Foundation to enable us to best serve our members and the broader cohort.
